RENNER SANITARY DISTRICT NEWSLETTER September, 2021

Major Events: We are seeing consistent low flows around the 47-52,000 gallons per day going to the City of Sioux Falls. Keep in mind during the flood of 2019 we had discharges to the City of Sioux Falls over 300,000 gals per day. It appears that the groundwater has been reduced to cause some with well water to lose their source or negatively affected. The positive is the District's sewage line has very little, if any infiltration.

Alarm System: Our new alarm system has been upgraded and is now operational. This upgrade will ensure a very timely and quick response by staff monitoring the lift stations and respond if anything goes wrong.

Preventative Maintenance: We conducted video inspections on some of the main lines this summer.

Some of you may have noticed that we are adding manhole markers. These are sometimes hard to locate for our subcontractors and for those doing grading. We are placing the markers in our easement, which is 10' either side of the sewer main. This should help eliminate future issues.

Meadowview upgrade project and town of Renner Project: This project consists of the installation of a sump pump collection system, lift station and pressure force main in the Meadowview Addition to convey sump pump discharge water to Silver Creek. For the next couple weeks, the Contractor installing the upgrades to the lift station and the storm water system in the Meadowview Addition will continue to install the sanitary sewer collection pipe on the west side of 115. 9th and 10th Avenue are completed as is everything on 75th,74th and 72nd St. Sump pump service lines will be stubbed off the main line in the street and being installed up to the houses. They are currently ahead of schedule so should be near the Monarch Lounge in Renner in a few weeks. Expected competition date is October 31.
