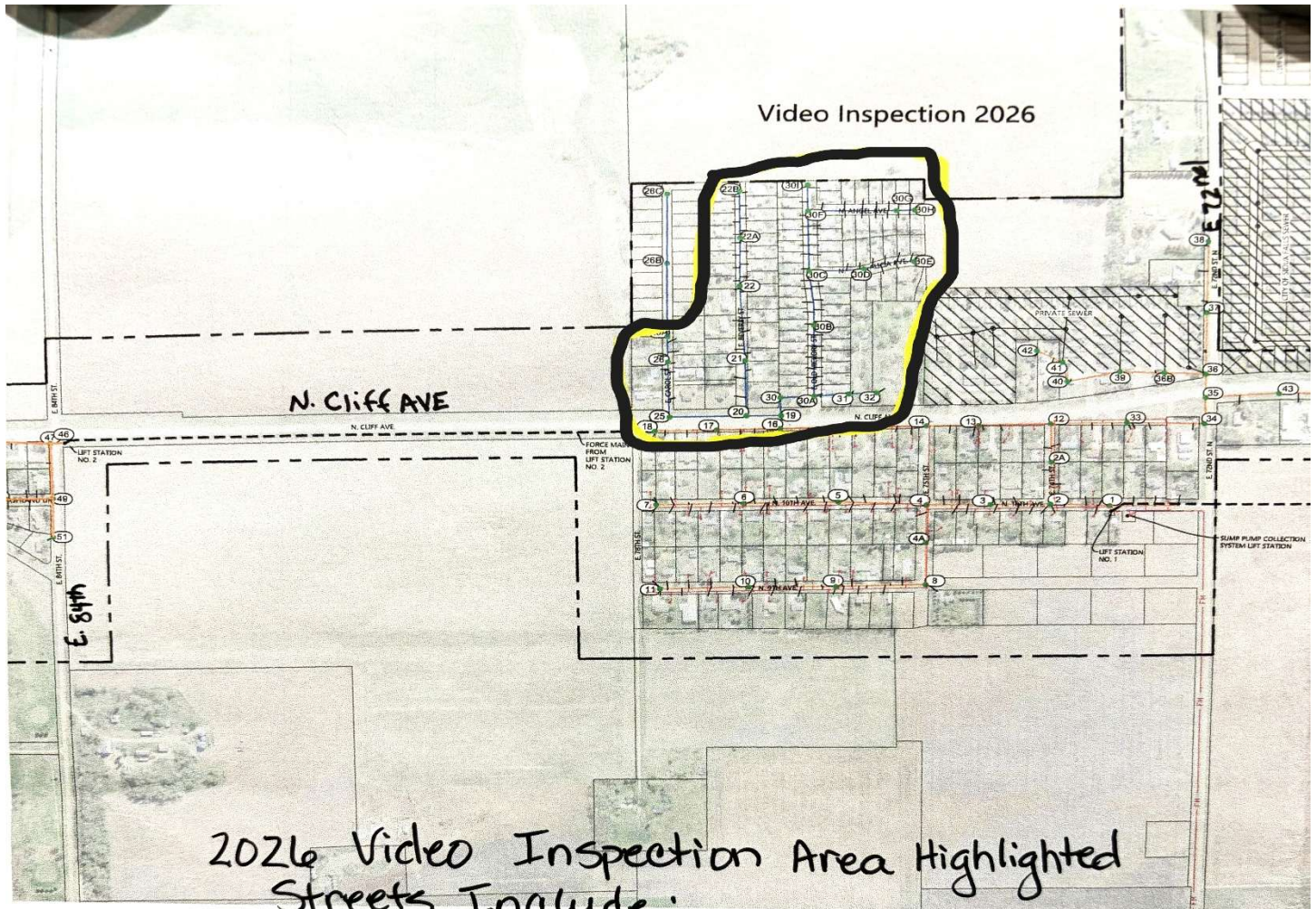
## April 2026

- **Video Inspection 2026:** There is a Video Inspection scheduled to take place in the Lift Station 1 area, beginning of May 2026. We will inspect 5,800ft of service on the East side of Cliff Avenue. Streets included are Carol, Beverly, Old Hickory, Alicia Ave, and Angel Ave. Please see the attached map located on the back for more details.
  - **Vacancy Filled:** On November 19, 2025, David Wilson was appointed and sworn in to continue as Trustee for the Renner Sanitary District. His term will last until 2028.
  - **Payments:** Here are some different ways that you can pay your Renner Sanitary Bill:
    - **Automatic Payments:** We do offer the ability to set up monthly Automatic Payments at no extra charge. Automatic payments will debit your account around the 10<sup>th</sup> of each month. Please let Natasha know if you are interested and she will send you the correct paperwork to get started.
    - **Drop Box:** The Renner Sanitary District has a drop box available to drop off payments or correspondence. It is located by the front entrance of the Jensen Electric Building – Renner Corner Area.
    - **Mail:** We do accept payments/checks via USPS – Note our address information at the bottom.
    - **Phone/Credit Cards:** We accept payments over the phone with a credit/debit card. We can also keep a card on file to make regular monthly payments. Please let Natasha know and she will send you the correct paperwork needed. However, there will be a 3.5% surcharge of the total bill when paying with a card. There is no profit or benefit for RSD with this surcharge. It has been put in place to offset all other credit card processing fees.
  - **Property Owner's Responsibility:** As a reminder, it is the current property owner's responsibility to inform the District if they have sold their property and notify them of a closing date. You must also inform your realtor or new owners that they must contact the District to change service over to their name at closing. Please inform them, that we are A Sewer Service for the area and not A Garbage Service. If the District is not notified, past due accounts will accumulate and there will be interest penalties assessed.
  - **Delinquent Accounts:** Please make sure your account is paid up to date! Any past due amount at the end of our fiscal year will be reported to the county Auditor and placed on the real estate tax rolls as per **SDCL-34A-5-40 Certification of unpaid charges and tax levies – collection with real estate taxes-**
  - **Regular Monthly Meetings:** Our regular monthly meetings are held at the Mapleton Township Hall/Fire Station at 6:00pm on the 3<sup>rd</sup> Tuesday of every month.
